Economic Futures is hosted by the University of Strathclyde and supports activities across all HE institutions in Scotland which have economics teaching provision.

Summer Placement Programme

Our Summer Placement Programme is the biggest and best applied economics placement programme in Scotland. Its unique nature helps to provide an ecosystem for students to gain experience as an applied economist in Scotland and build networks in the industry to aid throughout their career.

We offer 6-8 week work placements at organisations and educational institutions across Scotland, offering undergraduate students the opportunity to gain real world experience as an applied economist.

As part of this, we not only offer the opportunity for students network with other like-minded applied economists, but also earn the same salary as a newly qualified economist during their time on the programme, allowing them to commit to their placement in full during the summer.

The programme in numbers

2019: 75 applications received, and 8 placements provided

2020: 3 placements provided due to Covid

2021: 180 applications and 18 placements provided

2022: 150 applications received, and 19 placements provided

2023: 19 placements provided across 9 partners. **2024:** 15 placements provided across 12 partners

We are looking for organisations with research projects which a student could support (through applied analysis) for both our summer placement and sponsored dissertation programmes. For the placement programme, these posts are dedicated research posts with the students working as members of your team to undertake analysis on a topic of your choice.

Prior to applying, students are given the opportunity to express interest in a particular project. Projects will be allocated based on interests and skills.

During the placement, students are invited to attend two Economic Futures sessions, to meet other students on the programme, to network with other project teams, and to share the outputs of their work.

Sponsored Dissertations on the Scottish Graduate Programme in Economics

We faciliate the sponsored dissertation programme as part of the Scottish Graduate Programme in Economics (SGPE) at the University of Edinburgh.

The SGPE is a collaboration between eight Scottish universities and offers taught masters programmes in Economics, Economics with Econometrics and Economics and Finance.

Each year, the programme hosts high achieving, technical individuals and helps to develop the tools and skills necessary for PhD research or future careers in economics.

For our sponsored dissertation programme, we are looking for topics that are academically challenging and require a high level knowledge of economic theory and skill to conduct.

Based at The University of Strathclyde, each year we offer all of our partners the opportunity to meet and network with 150-200 undergraduate and postgraduate students from all Scottish universities.

Costings

One of the key features of an Economic Futures Summer Placement is the competitive hourly salary offered as part of the scheme. This allows students to fully commit to their work during their time with your organisation.

This also allows students to gain the full experience, to fully integrate within your teams, without the worries of household and other costs, which may require other summer employment to supplement.

In 2024, the hourly salary offered was £17.70, the starting hourly rate for a Research Assistant at The University of Strathclyde.

This year, we are moving to a flat rate structure for the programme to assist in the administrative element of the programme.

As part of this, you can choose to employ the student through the university, or employ them directly. This will likely alter any annual leave entitlement, but the commitment from your organisation when employing directly is to pay the EF hourly rate.

Costs for a placement are detailed below, with estimated annual leave provided for those employed through the university.

Placement Length	Annual Leave	Cost
6 Weeks	3.75 days	£5,000
7 Weeks	4 days	£5,750
8 Weeks	4.5 days	£6,500
9 Weeks	5 days	£7,250

Despite EF having overall control of the recruitment process of potential candidates, we offer partners the opportunity to engage in the sifting and interview process.

Organisations offering a placement are offered the opportunity to have 1 or more representatives to attend interviews to ensure that candidates are appropriately assesed for fit within your organisation.

For the cost of a 6-9 week placement, your organisation will also have the opportunity to offer topics as part of our sponsored dissertation programme, guaranteed attendance at our annual careers fair, and the opportunity to engage with students of school, undergraduate and postgraduate level.

We also offer the opportunity to share job opportunities within your organisation to our graduate network.
